## **ONTARIO CIVILIAN POLICE COMMISSION**

**IN THE MATTER** of an Application by The Corporation of the Town of Amherstburg to the Ontario Civilian Police Commission (the Commission) pursuant to section 5(1)(6) of the *Police Services Act*, R.S.O. 1990, c.P. 15 (the PSA) requesting the approval of the Commission to a Proposal (the Proposal) to have the Town of Amherstburg's policing services provided by the Windsor Police Service.

**AND IN THE MATTER** of an Application (the Application) by the Town of Amherstburg Police Services Board (the Board) requesting the consent of the Commission pursuant to section 40 of the PSA to the abolition of the Amherstburg Police Service.

The authority of the Commission under section 5(1)(6) the PSA is limited to deciding if the Proposal ensures the provision of **adequate and effective** policing services to the residents of the Town of Amherstburg.

The authority of the Commission under section 40 of the PSA is limited to deciding if the Application by the Board **does not contravene** the PSA and **to consent to the termination of the employment of a member** of the Amherstburg police force **if the conditions under section 40 have been satisfied.**

Any person wishing to make oral submissions to the Commission at the public meeting must provide notice to the Commission with their name and full contact information by e-mail to [OCPCRegistrar@ontario.ca](mailto:OCPCRegistrar@ontario.ca) no later than **Friday, June 15, 2018**. The Commission welcomes written submissions as well, to be delivered by that date.

The Commission may limit the time allowed for oral submissions and the number of oral submissions to be made at the public meeting.
